Once you have submitted an Expression of Interest Form, a representative from REIL will call you to arrange an Energy Audit on your home. This audit call will let you know if your home is eligible to participate in the scheme, which energy saving works would be of benefit to you and give you an initial outline of the potential cost of the energy improvement works.

On this call, a suitable time for a representative from REIL to visit your home to complete a full Energy Audit will be set up. There is no fee to complete the Energy Audit. If you participated in the 2015 scheme and paid a fee and participate in this year's scheme, the fee paid in 2015 will be refunded when works are complete.

The REIL Energy Audit Report will provide you with a list of recommended energy saving home improvements and the cost of each. A BER (Building Energy Rating) Cert will be issued to you before works commence by REIL.

The 35% grant will be deducted from the cost of the works. You will only need to borrow for 65% of the cost of the works.

You will then be contacted by St. Canice's Credit Union to make your loan application. All loan applications are subject to normal lending criteria.

When your loan is approved, we will inform REIL that the works can commence. Once the credit agreement is signed, the funds will be paid into your account for you to pay REIL directly for Energy Retrofit works completed on your home.

A BER (Building Energy Rating) Cert will be issued to you after works are completed by REIL.

As per the requirements of Data Protection Acts, 1988 & 2003 we hereby notify you that your personal details, specifically related to this scheme, will be shared with REIL (Retrofit Energy Ireland Limited) and SEAI (Sustainable Energy Authority of Ireland). SEAI will contact you to survey you about your experience with this Community Energy Loan Scheme whether or not you choose to go ahead with the work. SEAI may share personal data with third parties where necessary to assist in administering and delivering the scheme. You have the right to access personal data held about you by St. Canice's Credit Union, REIL and SEAI and to correct any inaccuracies in such data.
